




Q2 How would you rate Michael Locher's, Utilizing Incentives, material?







Q4 How would you rate the Gary Baum's knowledge of the topic, 10 things CPAs Should Know?





Q5 How would you rate Gary Baum's, 10 Things CPAs Should Know, material?





Q6 How would you rate Gary Baum's, 10 Things CPA's Should Know, presentation?







Q8 How would you rate Gary Thomson's, Navigating the Economical and Political Landscape, material?













Q13 How would you rate Danielle Aaronson's knowledge of the topic, Activate Your Leadership?




















